He maintained a general business practice with emphasis on taxation and business organizations and finance. In 2012, he received the President's Award for service to the Alabama Bar Association. In 2013, Gov. Robert Bentley appointed Justice Sellers to the Alabama State Council on the Arts. Since 2014, he has served as the community liaison with the International Officers School at Maxwell Air Force Base. He is past President of the Rotary Club of Montgomery, past Chair of the Montgomery Area Business Committee for the Arts, Chair of the River Region United Way Campaign in 2008, and past Chair of the YMCA of Greater Montgomery.



Will Hill Tankersley, a partner in Balch & Bingham's Birmingham office, is a 1986 admittee to the Bar. He holds a J.D. from the University of Alabama

School of Law and a LL.M. in Trade Regulation (Intellectual Property and Antitrust) from New York University Law School.
